Wally Lippincott Jr. Baltimore County Department of Planning - Northern Sector Planner, will discuss the current status of land preservation within the Hanover Road Association Inc's boundaries. Today because of Agricultural Land Preservation Programs many of the farms (Almost 8,000 acres) in our area is preserved. We encourage land owners to explore the many benefits of land preservation programs for estate planning, farming sustainability, and maintaining the quality of life we all enjoy.

Some of the measurable results are as follows:

(1) HRA officially becoming a 501(c) 3 non-profit organization. Being tax-exempt under IRS Section 501(c) 3 gives the ability for the HRA to accept contributions and donations that are tax-deductible to the donor. Therefore, your membership contribution and or donations are tax-deductible.

(2) Provided educational forum opportunities for local political representatives, running for office, to present their qualifications.

(3) Working with Dave Kirby, Baltimore County Office of Code Enforcement: a. Inappropriate business signs ordered to be taken down, b. several abandoned untagged vehicles have been removed or notices issued for their removal, c. several vacant properties have been cleaned up.

(4) Recognized the Honorable T. Brian McIntire District 3 Councilman (retired) with an Honorary Membership in the HRA for his sixteen years in office resulting in extensive land preservation.

(5) Meeting Speakers: a. Master Gardener presentation on best garden practices, b. Agronomist presentation on modern farming technology

(6) Initiated request through Colonel Adam R. Flasch, for a USDA Camp Fretterd deer hunt resulting in 83 deer culled from the herd. This herd reduction significantly reduced crop damage and fewer deer being struck by motorists on Route 30. The deer meat was processed and donated to the Maryland Food Bank.

(7) Adopt-A-Highway Program coordinated by John Lorenz and his team of volunteers kept the HRA area of Hanover Pike pristine by numerous cleanups of litter.

(8) Worked with the Baltimore Gas and Electric Company to properly relocate the new power substation from the proposed Camp Holiday site to a more suitable location near Glyndon Gardens, reducing tree destruction along Hanover Pike and traffic jams on Kemp Road.

(9) Carefully monitored HRA Covenants with property/business for sale along Hanover Pike.

(10) Supported and assisted with Zoning Appeals for HRA property owners. Recently supported the first RC8 Zoning Appeal in Baltimore County.

The Board and I have enjoyed working with you in a "Partnership in Caring" to Preserve the Rural Character of Our Community.

Fowlesburg Motors was started by Walter Armacost and provided towing services and sold multiple grades of gasoline. In 1956, Leroy (Roy) Hale, an employee of Mr. Armacost, bought the business, a full service garage, and rented the real estate from Walter. After working a few years for Roy Hale as an apprentice mechanic, Jim Bosley bought the business from Roy in November 1964.

The business in the 70's employed five employees with Jim's wife Sue as the bookkeeper, until her death in 2013. In 1996 Jim had the gas pumps removed and started working by himself. When not at his garage, Jim is very involved with the Boring Volunteer Fire Department and is an active member of the Mason Dixon and the Maryland Steam Historical Society.
