Message from the President

Special Exception Zoning Hearing – 14419 Old Hanover Road - On December 19, 2006 a Special Exception Hearing was held at the request of Mr. Lee Yachimowicz owner of Leyland Nursery. The request was to allow a Horticultural Nursery and Landscape Service Operation on RC-2 zone property.

After listening to the concerns of the community, visiting the property and meeting with Mr. Yachimowicz an agreement was reached to limit development and activities. The Honorable William J. Wiseman, III, Zoning Commissioner for Baltimore County incorporated the agreement elements into his decision rendered on December 19, 2006. They are as follows:

- A building permit may be obtained to construct a new storage building as requested.
- An earth berm with landscape evergreen-type plantings will be constructed to buffer the view of parking areas and the new building.
- New structures to be limited to 24 feet maximum height.
- No business signage, retail sales or firewood operation or waste disposal permitted on premises.
- No additional structural improvements permitted at this site (3.15 acres) without a public hearing.
- There shall be no more than 15 commercial vehicles stored on the property at any one time.
- Limitations imposed on size of trucks and hours of operation.
- The maximum number of employees shall at no time exceed 20 in number.

These conditions are intended to run with the land and bind the Petitioner and his successor and assigns.
